**Directions to the Site:**

**From I-5 or Highway 167:** Take Highway 18 east toward Auburn. Take the Auburn-Black Diamond Exit off to the right. At end of off ramp turn right, then immediately right again onto SE Green Valley Rd. Proceed 7.2 miles to 212<sup>th</sup> Way SE, just beyond a green girder bridge sitting on land. Turn right onto 212<sup>th</sup> Way SE, cross the bridge, and then turn left into Argus Ranch. Follow the signs to the lure field.

**From I-90 east of Issaquah:** Take the Highway 18 exit and proceed west toward Maple Valley and Auburn, crossing over Tiger Mountain Pass. Take the Maple Valley exit. At the end of the exit ramp turn left toward Maple Valley and then turn right onto Highway 169 (Maple Valley-Black Diamond Rd.) heading toward Black Diamond and Enumclaw. ## ELIGIBLE BREEDS AND REGISTRY

Only purebred Afghan Hounds, Basenjjs, Borzoi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, and Whippets that are one year of age or older and have been registered with The American Kennel Club, or are part of an AKC-registered litter, or otherwise if whelped outside of the USA and owned by a resident of the USA, or of a country with a foreign registry whose pedigrees are acceptable for AKC registration and are registered with that registry, or that have been granted an Indefinite Listing Privilege (IPL) may be entered. Hounds may not be entered as Registration Pending or ILP Pending. Sloughs one year of age or older that have been registered with the Foundation Stock Service, or that have been granted an ILP, are eligible to enter in Lure Coursing Tests and may participate in Lure Coursing Trials on an Exhibition-Only basis. Breed disqualifications apply.

## RIBBONS

Evergreen Basenji Club will offer:

**TEST:** Qualifying Course = Green Ribbon  
**TRIAL:** Rosettes: First = Blue, Second = Red, Third = Yellow, Fourth = White,  
Fifth = Pink, Best of Breed = Purple/Gold. Best in Field = Red, White, and Blue.

## TROPHIES

Trophies will be offered for **Best of Breed** and **Best in Field**.

## STAKES OFFERED

**JUNIOR COURSER TEST:** Open to all hounds of an eligible breed. A hound running alone shall receive a certification from a Judge on one date and a second certification from a different Judge at a later date, stating that the hound completed a six hundred (600) yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption.

**\*\*\*\*IT IS RECOMMENDED THAT JUNIOR COURSER HOUNDS ENTERING THE OPEN STAKE FOR THE FIRST TIME HAVE SUCCESSFUL PRACTICE EXPERIENCE WITH OTHER HOUNDS BEFORE COMPETING.\*\*\*\***

**OPEN:** Open to all hounds of an eligible breed that have attained at least one of the following: AKC Junior Coursing Title, or AKC Field Championship Title. Hounds that are disqualified (or dismissed twice within six (6) trials) from Lure Trials may not be entered.

**OPEN VETERAN:** Open to all hounds that are eligible to enter Open or Special Stakes and meet the age requirement for a veteran as established by the breed's parent club. Championship points will be awarded.

**SPECIALS:** Open to all hounds of an eligible breed that are eligible to enter the Open Stake and have earned their AKC Field Champion Title. Specials may compete for LCX points.

**BEST IN FIELD WILL BE OFFERED:** All Best of Breed winners, **with the exception of Italian Greyhounds**, shall be eligible to compete in the Best in Field competition.

## GENERAL

1. All entries must be one year of age or older on the day of the trial.
2. Stakes shall be split each time the entry is sufficient to hold two or more five point majors.
3. All hounds will run alone in the Test. In the Trial, all hounds will run twice, in trios if possible, or braces, unless excused, dismissed, or disqualified.
4. Hounds not present at the time of roll call will be scratched after a five (5) minute grace period. Each entry will be examined at inspection for breed disqualifications, bitches in season, and lame hounds, which will be excused and their entry fees refunded. Spayed or neutered hounds without breed disqualifications may be entered.
5. Battery powered **continuous loop** machines will be used. Lure will consist of white plastic bags. Backup equipment will be available.
6. The course will be reversed for the finals and run-offs.
7. The field committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
8. **THE FIELD COMMITTEE RESERVES THE RIGHT TO BAR KNOWN AGGRESSIVE HOUNDS FROM THE TRIAL SITE.**
9. **THERE WILL BE A \$5.00 FINE ASSESSED FOR ANY LOOSE HOUND NOT TAKING PART IN THE COURSE IN PROGRESS, OR FOR ANYONE NOT PICKING UP AFTER THEIR OWN DOG(S). ALL TRASH, INCLUDING DOG FECES, MUST BE HAULED AWAY BY THE OWNER.**
10. **PLEASE BRING YOUR OWN SHADE, FOOD, AND WATER.**

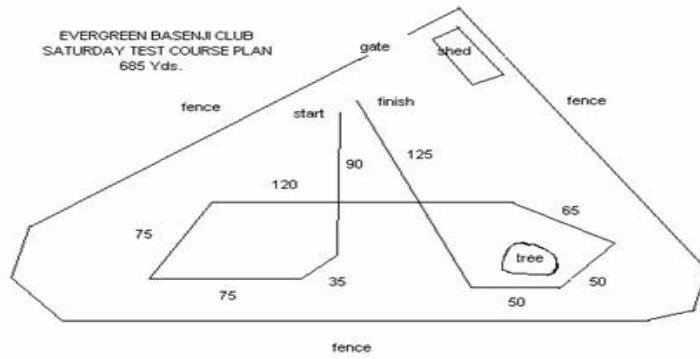

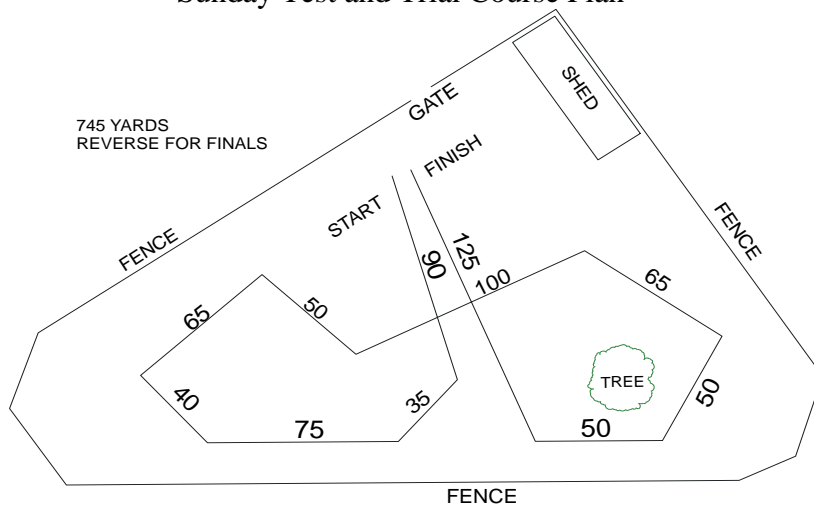

Additionally, I (we) hereby assume the sole responsibility for and agree to indemnify, defend and save the aforementioned parties harmless from any and all loss and expense (including legal fees) by reason of the liability imposed by law upon any of the aforementioned parties for damage because of bodily injuries, including death at any time resulting therefrom, sustained by any person or persons, including myself (ourselves) or on account of damage to property, arising out of or in consequence of my (our) participation in this event, however such, injuries death or property damage may be caused, and whether or not the same may have been caused or may be alleged to have been caused by the negligence of the aforementioned parties or any of their employees, agents, or any other persons. **I (WE) AGREE THAT ANY CAUSE OF ACTION, CONTROVERSY OR CLAIM ARISING OUT OF OR RELATED TO THE ENTRY, EXHIBITION OR ATTENDANCE AT THE EVENT BETWEEN THE AKC AND MYSELF (OURSELVES) OR AS TO THE CONSTRUCTION, INTERPRETATION AND EFFECT OF THIS AGREEMENT SHALL BE SETTLED BY ARBITRATION PURSUANT TO THE APPLICABLE RULES OF THE AMERICAN ARBITRATION ASSOCIATION. HOWEVER, PRIOR TO ARBITRATION ALL APPLICABLE AKC BYLAWS, RULES, REGULATIONS AND PROCEDURES MUST FIRST BE FOLLOWED AS SET FORTH IN THE AKC CHARTER AND BYLAWS, RULES, REGULATIONS, PUBLISHED POLICIES AND GUIDELINES.**
