### Driving Directions:

**From the North:** From I-5 take exit #127 (Hwy 512 Puyallup exit) towards Puyallup. Take the Pacific Ave exit (Hwy 7) and turn right. Go south on Pacific Ave approx. 5 miles to the Roy "Y" and bear right on WA-507/Spanaway McKenna Hwy. Go 1.2 miles and turn slight left onto 8th Ave. Go 5.2 miles (just after crossing 288th St.) turn left into the entrance to the Polo Field on a dirt road marked signage. Follow dirt road to field.

**From the South:** Take I-5 exit 88A (Tenino exit) and follow to Yelm. Turn right at the stop light and follow to McKenna. Turn right at stop light in McKenna (Exxon station) on Hwy 702/352nd St. Go 5.3 miles to flashing yellow light and turn left on 8th Ave. Go approx. 3.5 miles. The Polo Field is down a dirt road in the trees on the right just before the 288th Street intersection, and will be marked with signage. Follow dirt road to field.

Early inspection will be conducted after the start of trial hours and before official roll call time – you are encouraged, but not required, to inspect your hounds early; hounds not present by completion of roll call will be marked absent.

### Eligible Breeds and Registry

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, and Whippets may be entered in the regular stakes. Limited and Provisional stake breeds are listed in each issue of the Field Advisory News, the current list consists of: Chart Polskis, Cirneco dell'Etnas, Galgo Espanols, Magyar Agars, Peruvian Inca Orchids, and Portuguese Podengos. All entries in the regular stakes shall be individually registered with the American Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry, or possess a critique registration number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Limited and/or Provisional stake entries shall be individually registered with the appropriate registry.

### Regular Stakes

*All hounds entering Open, Veteran or Limited stakes for the first time must include a completed certification form or waiver (all breeds) and a copy of the hound's registration certificate with their entry (waived for NGA Greyhounds only).*

**OPEN:** Any eligible sighthound, excluding ASFA Field Champions of record.

**FIELD CHAMPION:** Any ASFA Field Champion.

**VETERAN:** Any eligible sighthound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Rhodesian Ridgebacks and Whippets, whose age shall be at least seven years.

**LIMITED:** Any eligible sighthound of a Limited or Provisional Stake breed that has met certification requirements.

**SINGLES:** Any eligible sighthound, including those disqualified to run in other stakes. No certification required. No ASFA points or placements toward titles awarded, and stake winner is not eligible for BIF.

**BEST IN FIELD** will be offered both days.

### General Rules & Guidelines

All entries must be one year of age or older on the day of the trial. Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more. Hounds not present at the time of roll call will be scratched. Each entry will be examined at inspection for breed disqualifications. Bitches in season, hounds with breed disqualifications, and lame hounds will be excused. Entry fee for hounds excused during inspection for bitches in season, lameness or breed disqualification shall be refunded. Substitutions allowed if submitted prior to close of entries. Spayed or neutered hounds without breed disqualifications may be entered. Hound certifications will be offered before the Saturday trial only; see front cover for details and requirements. Battery powered DRAG lure machine will be used. Lure will consist of white plastic bags. A \$5 penalty will be assessed for any loose hound on the trial site not competing in the course in progress. No alcoholic beverages will be permitted on the site. The Field Committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial. Please pick up after yourself and your dog(s); you are responsible for packing out your own garbage, including dog poop; a \$5 fine will be assessed to anyone caught littering or not picking up after their dog. Persons exhibiting unsportsmanlike conduct detrimental to WWWA, ASFA, Roy Polo Field, any hound, or other person will be asked to leave the trial site and may be subject to further disciplinary action.

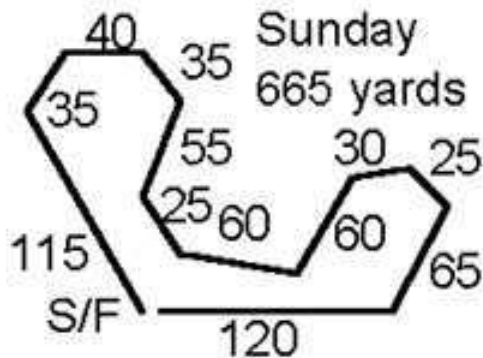
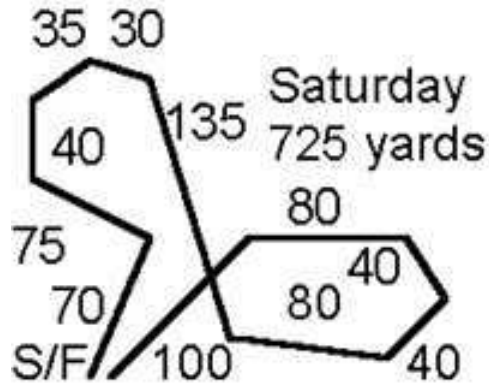
