Directions to the Site:

From I-5 or Highway 167: Take Highway 18 east toward Auburn. Take the Auburn-Black Diamond Exit off to the right. At end of off ramp turn right, then immediately right again onto SE Green Valley Rd. Proceed 7.2 miles to 212th Way SE, just beyond a green girder bridge sitting on land. Turn right onto 212th Way SE, cross the bridge, and then turn left into Argus Ranch. Follow the signs to the lure field.

From I-90 east of Issaquah: Take the Highway 18 exit and proceed west toward Maple Valley and Auburn, crossing over Tiger Mountain Pass. Take the Maple Valley exit. At the end of the exit ramp turn left toward Maple Valley and then turn right onto Highway 169 (Maple Valley-Black Diamond Rd.) heading toward Black Diamond and Enumclaw. Go through Black Diamond and about a mile south of town watch for signs pointing to Flaming Geyser State Park. Turn right (west) onto SE Green Valley Rd. A half mile after passing the entrance to the state park, turn left onto 212th Way SE, cross the bridge, and then turn left into Argus Ranch. Follow the signs to the lure coursing field.

REGULAR STAKES OFFERED

OPEN: Open to any Basenji that has met Certification requirements that is not an ASFA Field Champion of Record. All first-time entries must be accompanied by a signed Hound Certification Form and copy of the AKC Registration Certificate.

FIELD CHAMPION: Any Basenji that is an ASFA Field Champion.

VETERAN: Open to any Basenji that has met Certification requirements and is at least six years old. All first-time entries must be accompanied by a signed Hound Certification Form and copy of the AKC Registration Certificate.

SINGLES: Any eligible Basenji including those disqualified to run in other stakes. Points are not awarded. Basenjjs run alone and are not eligible to run in Best of Breed.

NON-REGULAR STAKES OFFERED

BREEDER STAKE: For any two Basenjjs, designated at time of entry, bred by the same person.

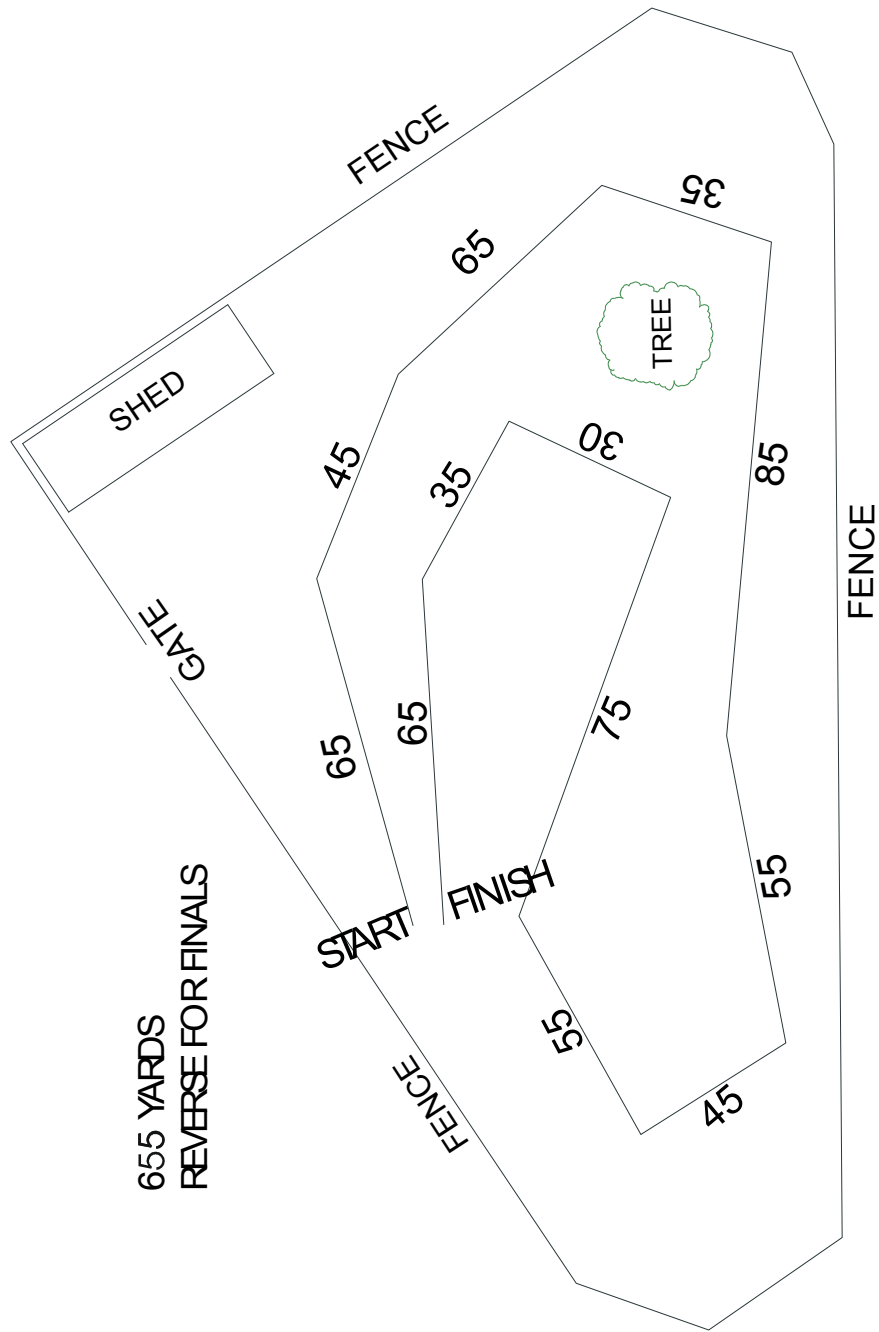
KENNEL STAKE: For any two Basenjjs, designated at time of entry, owned and kenneled by the same person.

GENERAL

1. All entries must be one year of age or older on the day of the trial.
2. Stakes shall be split by public random draw if the entry in any one stake is 20 or more at the time of the draw.
3. In the Trial, all Basenjjs will run twice, in trios if possible, or braces, unless excused, dismissed, or disqualified.
4. Basenjjs not present at the time of roll call will be scratched. Each entry will be examined at inspection for breed disqualifications. Bitches in season, Basenjjs with breed disqualifications, and lame hounds will be excused. Entry fees for Basenjjs excused during inspection will be refunded. Spayed or neutered Basenjjs and monorchid or crytorchid Basenjjs without breed disqualifications may be entered.
5. Battery powered **continuous loop** machines will be used. Lure will consist of white plastic bags. The course will be reversed for the finals and run-offs. Backup equipment will be available.
6. The field committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
7. **Certifications will be limited to 10 Basenjjs, offered before the trial by early entry only.**
8. **THE FIELD COMMITTEE RESERVES THE RIGHT TO BAR KNOWN AGGRESSIVE BASENJS FROM THE TRIAL SITE.**
9. **THERE WILL BE A \$5.00 FINE ASSESSED FOR ANY LOOSE BASENJI NOT TAKING PART IN THE COURSE IN PROGRESS, OR FOR ANYONE NOT PICKING UP AFTER THEIR OWN DOG(S).**
10. **PLEASE BRING YOUR OWN SHADE AND WATER.**
11. **NO ONE, EXCEPT FIELD COMMITTEE, WILL BE ALLOWED ON THE FIELD WITHOUT EXPRESS PERMISSION OF THE FIELD CHAIRMAN.**
12. Anyone exhibiting unsportsmanlike conduct will be excused from the field for the day.
13. No cigarette smoking permitted on this working farm field.
