Eligible Breeds & Registry

Only purebred Afghan Hounds, Azawahks, Basenjis, Borzoi, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Portugese Podengos, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Thai Ridgeback and Whippets that are one year of age or older and have been registered with the America Kennel Club or part of an AKC-registered litter, or otherwise, if whelped outside of the United States of America and owned by a resident of the USA, or of a country with a foreign registry organization whose pedigrees are acceptable for AKC registration and is registered with that registry, or that have been granted an Indefinite Listing Privilege (ILP), are eligible to participate in lure coursing tests and trials. Hounds may not be entered as "registration pending" or "IPL Pending." Sloughis one year of age or older, that have been recorded with the Foundation Stock Service, or that have been granted an ILP are eligible to enter in Lure Coursing Tests and may participate in Lure Coursing Trials. ****Note: Italian Greyhounds are not eligible to compete for Best in Field.****

ENTRIES WILL NOT BE ACKNOWLEDGED BY MAIL

JUNIOR COURSER (JC) TEST: A hound running alone shall receive a certification from a judge on one date, and a second certification from a different judge at a later date, stating that the hound completed a 600 yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption. **It is recommended that Junior Courser hounds entering the Open Stake for the first time have successful practice experience with other hounds before competing.**

TRIAL STAKES OFFERED

OPEN: Open to all eligible hounds that have attained an AKC JC Title. Hounds that have been disqualified from trials may not be entered.

SPECIAL: Open to all eligible hounds that have earned an AKC Field Champion Title. No championship points will be awarded from this stake. (LCX points will be awarded.)

OPEN VETERAN: Open to all hounds eligible to enter Open or Special Stakes who meet age requirement for a Veteran as established by the breed's parent club. Championship points will be awarded.

BEST IN FIELD WILL BE OFFERED

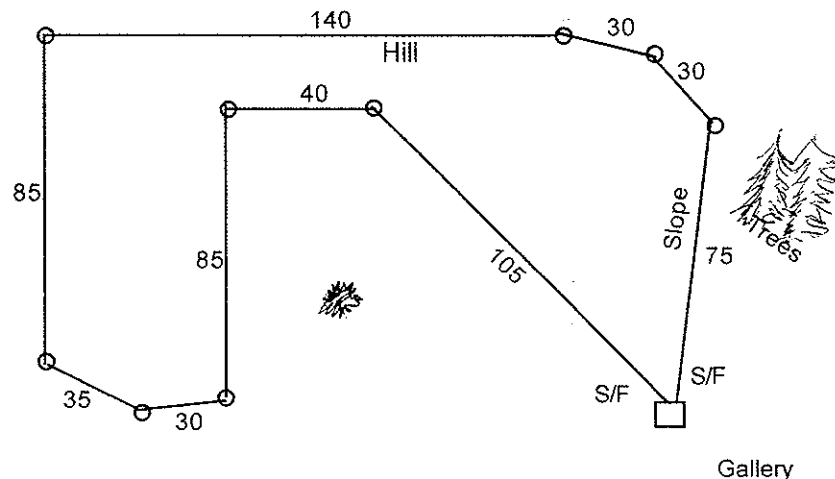

All hounds will run twice, in trios, if possible, or braces unless excused, dismissed or disqualified. Bitches in season and lame hounds will be excused. Hounds not present at Roll Call will be scratched after a 5 minute grace period. Each entry will be examined at inspection for AKC breed disqualifications. Spayed and neutered hounds, without breed disqualifications, may be entered. A battery powered, continuous loop lure machine will be used. Back up machines will be available. The lure will consist of highly visible white plastic. A \$5.00 fine will be assessed for any loose hound on the field not competing in the course in progress. No cell phones allowed on field.

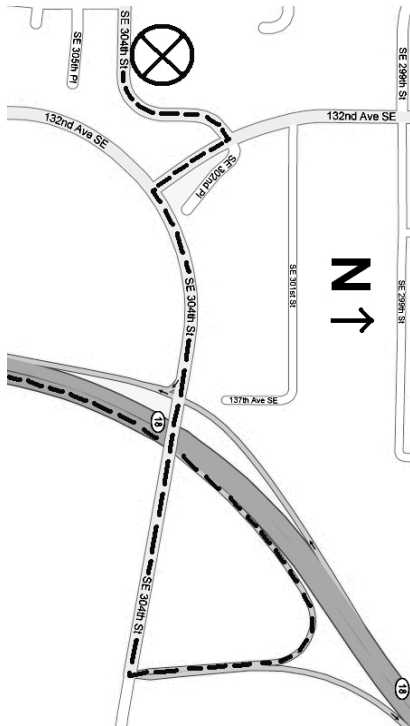

JUNIOR COURSER TEST: Open to all hounds of an eligible breed. A hound running alone shall receive a certification from a Judge on one date and a second certification from a different Judge at a later date, stating that the hound completed a six hundred (600) yard course with a minimum of four (4) turns. The hound must complete the course with enthusiasm and without interruption.

******IT IS RECOMMENDED THAT JUNIOR COURSER HOUNDS ENTERING 1 OPEN STAKE FOR THE FIRST TIME HAVE SUCCESSFUL PRACTICE EXPERIENCE WITH OTHER HOUNDS BEFORE COMPETING.******

OPEN: Open to all hounds from an eligible breed that have obtained an AKC Junior Court title. This requirement will be waived for hounds that have earned a Field Championship from the ASFA or the CKC. ASFA or CKC Field Champions must submit a copy of their title certificate to the host club when they enter their first AKC Open Stake. The copy must be included when the results of the trial are sent to AKC. Hounds that have earned an AKC Field Championship are not eligible to enter the open Stake.

OPEN VETERAN: Open to all hounds that are eligible to enter Open or Special Stakes meet the age requirement for a veteran as established by the breed's parent club. Championship points will be awarded.

SPECIALS: Open to all hounds of an eligible breed that are eligible to enter the Open Stake and have earned their AKC Field Championship Title. Specials may compete for LCX points

BEST IN FIELD WILL BE OFFERED: All Best of Breed winners, **with the exception of Italian Greyhounds**, shall be eligible to compete in the Best in Field competition.

GENERAL

1. All entries must be one year of age or older on the day of the trial.
2. Stakes shall be split each time the entry is sufficient to hold two or more five point majors.
3. All hounds will run alone in the Test. In the Trial, all hounds will run twice, in trios if possible braces, unless excused, dismissed, or disqualified.
4. Hounds not present at the time of roll call will be scratched after a five (5) minute grace period. Each entry will be examined at inspection for breed disqualifications, bitches in season, and lar hounds, which will be excused and their entry fees refunded. Spayed or neutered hounds with breed disqualifications may be entered.
5. Battery powered **continuous loop** machines will be used. Lure will consist of white plastic bag. Backup equipment will be available.
6. The course will be reversed for the finals and run-offs.
7. The field committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
8. **THE FIELD COMMITTEE RESERVES THE RIGHT TO BAR KNOWN AGGRESSIVE HOUNDS FROM THE TRIAL SITE.**

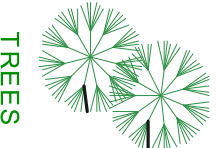
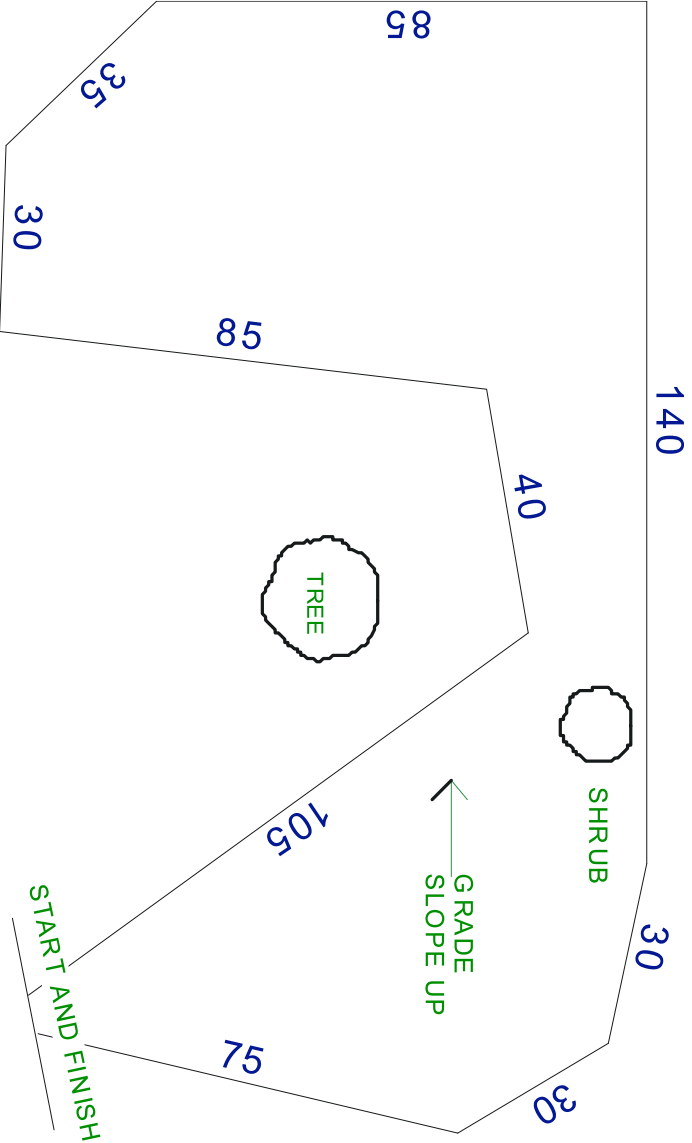
