**DIRECTIONS TO THE FIELD:** Exhibition Park is located at the NE corner of MacLure Road and Trethewey Street. From Highway 1 – take Exit 87 (Clearbrook Road) and go north. Continue on Clearbrook Road thru about 8 traffic lights (it changes all the time!). Turn right onto MacLure Road (Gordie Howe School on the right corner). Turn left at the next light onto Trethewey/Haida Drive (Rotary Stadium on left corner). Follow Haida to entrance on your right. Once entering gates, make an immediate right turn and follow road to the soccer fields beside the stadium.
