**Directions to the Site:**

**From the North:** From I-5 take exit #127 (Hwy 512 Puyallup exit) toward Puyallup.

- Take the Pacific Ave. exit (Hwy 7) and turn right.
- Go South on Pacific Ave. approx. 5 miles to the Roy "Y" and bear right on WA-507/Spawaway McKenna Hwy.
- Go 1.2 miles and turn slight left onto 8th Ave. Continue another 5.2 miles. Just after crossing 288th St. (flashing yellow light), turn left into the entrance to the Polo Field on a dirt road marked with signage. Follow dirt road to field.

**From the South:** Take I-5 exit 88A (Tenino exit) and follow to Yelm.

- Turn right at the stop light and follow to McKenna.
- Turn right at the stop light in McKenna (Union 76) on Hwy 702/352nd St.
- Go 5.3 miles to the flashing yellow light and turn left on 8th Ave.
- Go approx. 3.5 miles. The Roy Polo Field is down a dirt road in the trees on the right, just before the 288th St. intersection (flashing yellow light), and will be marked with signage.

**ELIGIBLE BREEDS AND REGISTRY:** Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzoi, Cirneci dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets and Provisional breeds, if any, may be entered in the regular stakes. Limited stake breeds, if any, may be entered in Limited Stake and currently include purebred Chart Polskis, Galgo Españols, Magyar Agars, Peruvian Inca Orchids, Portuguese Podengos and Silken Windhounds.

All entries in the regular stakes shall be individually registered with the American Kennel Club, the United Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Dogs with an Indefinite Listing Privilege (ILP) or a Purebred Alternate Listing (PAL) from the AKC shall be considered registered with that body. Limited and/or Provisional stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for Greyhounds registered with the National Greyhound Association registry.

**RIBBONS:** First = Blue, Second = Red, Third = Yellow, Fourth = White, NBQ = Green,  
BOB = Purple/Gold, BIF = Red, White, and Blue

**TROPHIES:** Best of Breed and Best in Field.

## REGULAR STAKES OFFERED

**OPEN:** Any eligible sighthound, excluding ASFA Field Champions of record.

**FIELD CHAMPION:** Any ASFA Field Champion.

**VETERAN:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Ridgebacks and Whippets whose age shall be at least seven years. Points & placements go toward V-FCH & V-LCM titles.

**LIMITED:** Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field.

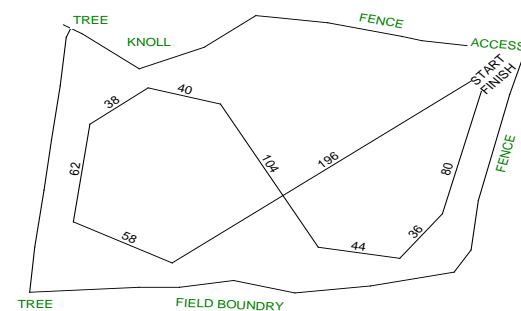
**SINGLE:** Any eligible sighthound including those disqualified to run in other stakes. Not eligible to compete in Best of Breed or Best in Field.

**BEST IN FIELD** will be offered.

## GENERAL

1. All entries must be one year of age or older on the day of the trial. All first-time entries must be accompanied by a signed Hound Certification Form and copy of the AKC Registration Certificate.
2. Stakes shall be split by public random draw if the entry in any one stake is 20 or more.
3. In the Trial, all hounds will run twice, in trios if possible, or braces (except in the Single Stake), unless excused, dismissed, or disqualified.
4. Hounds not present at the time of roll call will be scratched. Each entry will be examined at inspection for breed disqualifications. Bitches in season, hounds with breed disqualifications, and lame hounds will be excused. Entry fees for hounds excused during inspection will be refunded. Spayed or neutered hounds and monorchid or crytorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
5. Battery powered **continuous loop** machines will be used. Lure will consist of white plastic bags. The course will be reversed for the finals and run-offs. Backup equipment will be available.
6. The field committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
7. **THE FIELD COMMITTEE RESERVES THE RIGHT TO BAR KNOWN AGGRESSIVE HOUNDS FROM THE TRIAL SITE.**
8. **Certifications will be offered before the trial by early entry only.**
9. **THERE WILL BE A \$5.00 FINE ASSESSED FOR ANY LOOSE HOUND NOT TAKING PART IN THE COURSE IN PROGRESS, OR FOR ANYONE NOT PICKING UP AFTER THEIR OWN DOG(S).**
10. **PLEASE BRING YOUR OWN SHADE AND WATER.**
11. **NO ONE, EXCEPT FIELD COMMITTEE, WILL BE ALLOWED ON THE FIELD WITHOUT EXPRESS PERMISSION OF THE FIELD CHAIRMAN.**
