Directions:

From the North: From Southbound I-205 take **exit 17** for Foster Rd. Turn **left** on **Woodstock Blvd** for .3 miles and then a slight **right** onto **Foster Rd**, continue on Foster Rd. for 4.9 miles. Take a slight **left** onto **Tillstrom Rd**, continue on Tillstrom Rd for 1.7 miles. Take a slight **right** onto **SE Bohna Park Rd**. for .1 mile and take the first **right** onto **SE Wiese Rd**. The field is .8 miles ahead on the left.

From the South: On Northbound I-205 take **exit 12** for OR-212 E/OR-224 E toward Estacada/Mt Hood. Turn **right** on **Carver Rd/OR-212 E**. Continue to follow OR-212 E for 6 miles. Turn **left** onto **SE Wiese Rd**. The field is .7 miles ahead on the right.

LIMITED ENTRY: Trial entry limited to 50 dogs

Trial Roll Call: 9:00 AM or 15 minutes after the last certification run completes, whichever time is *later*. All hounds must be inspected prior to roll call.

No phone, fax, or e-mail entries will be accepted. Please **mail** early.

No late, incomplete, unsigned, unpaid, or conditional entries will be accepted.

Entries will be acknowledged by e-mail if e-mail address is legible on entry form.

Entries will not be acknowledged by mail or telephone.

Ribbons awarded for all placements – 1st through NBQ, Best of Breed and Best in Field.

Eligible Breeds & Registry:

Only purebred Afghan Hounds, Azawakhs, Basenjis, Borzois, Cirnechi dell'Etna, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughis, Whippets and Provisional breeds, if any, may be entered in the regular stakes. Limited stake breeds, if any, are entered in the Limited Stake and currently include purebred Chart Polskis, Galgo Españols, Magyar Agars, Peruvian Inca Orchids, Portuguese Podengos and Silken Windhounds.

All entries in the regular stakes shall be individually registered with the American Kennel Club, the United Kennel Club, the National Greyhound Association, the Federation Cynologique Internationale, an ASFA-recognized foreign or ASFA Board approved registry, or possess a Critique Registration Number (CRN) from the Society for the Perpetuation of Desert Bred Salukis (SPDBS). Dogs with an Indefinite Listing Privilege (ILP) or a Purebred Alternate Listing (PAL) from the AKC shall be considered registered with that body. Limited and/or Provisional stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for Greyhounds registered with the National Greyhound Association registry.

Regular Stakes:

All hounds entering Open, Veteran, or Limited stakes for the first time **must** include a completed ASFA Certification Form or Waiver form (with proof of title) and a copy of the hound's registration certificate with their entry (registration requirement waived for NGA Greyhounds only; certification waived for Single Stake entries only).

Stakes Offered:

OPEN: Any eligible sighthound, excluding ASFA Field Champions of record.

FIELD CHAMPION: Any ASFA Field Champion.

VETERAN: Any eligible hound whose age is at least six years, except Irish Wolfhounds, whose age shall be at least five years, and Rhodesian Ridgebacks and Whippets, whose age shall be at least seven years. Points and placements go toward V-FCH and V-LCM titles.

LIMITED: Any eligible sighthound of a Limited or Provisional stake breed that has met certification requirements. Not eligible to compete in BOB or BIF.

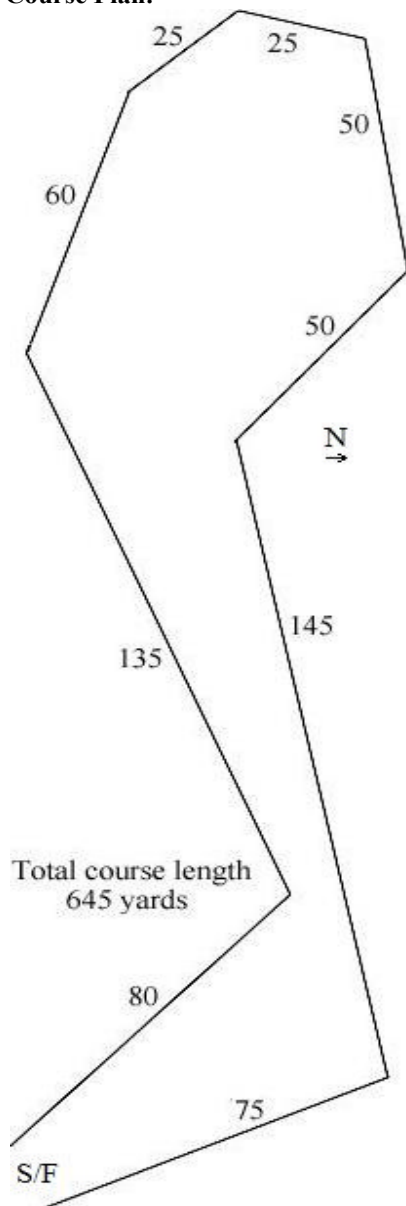
SINGLES: Any eligible sighthound, including those disqualified from running in other stakes. No certification required. No ASFA points or placements toward titles awarded, and stake winner is not eligible for BIF. Not eligible to compete in BOB or BIF.

BEST IN FIELD WILL BE OFFERED.

General:

- All entries must be one year of age or older on the day of the trial.
- Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more.
- Bitches in season, lame hounds, and hounds with breed disqualifications will be excused at roll call. Entry fees will be refunded for these hounds.
- Spayed, neutered, monorchid, and cryptorchid hounds without breed disqualifications may be entered.
- Hounds with breed disqualifications are not eligible to enter except in the Single Stake.
- Hounds not present at the time of roll call will be scratched.
- All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified.
- Hound certification runs will be offered starting at 7:45am. See front cover for details and requirements.
- Battery powered drag lure machine will be used. Lure will consist of white plastic bags. Backup equipment will be provided.
- The field committee reserves the right to alter the course plan as required by weather and/or field conditions on the day of the trial.
- The field committee reserves the right to bar known aggressive hounds from the trial site.
- There will be a \$5 fine assessed for any loose hound not taking part in the course in progress, or for anybody caught not picking up after their dog or leaving garbage on the field. You are responsible for packing out your own garbage.
- NO ONE will be allowed on the field without the express permission of the field chairperson, except the appointed field committee.
- Anybody exhibiting unsportsmanlike behavior will be excused from the field and may be subject to further disciplinary action.
- Control of dogs strictly enforced, on leash at all times except when running.
- No smoking will be allowed on or around the trial grounds.

No camping allowed at the field.
