Eligibility: For Silken Windhounds. All entries in this trial shall be individually registered with the International Silken Windhound Society. A copy of the registration must accompany the hound's first ASFA entry. Spayed and neutered hounds are eligible to enter.

**STAKES OFFERED:**

**LIMITED STAKE:** Open to all Silken Windhounds that have successfully completed an ASFA certification run.

**SINGLE STAKE:** Any Silken Windhound including those disqualified to run in other stakes.

**BEST IN FIELD WILL NOT BE OFFERED**

**Conditions of Entry:** All entries must be one year or older on the day of the trial • Stakes will be split into flights by public random draw if the entry in any regular stake is 20 or more • Bitches in season, lame hounds and hounds with breed disqualifications will be excused at roll call. Spayed, neutered, monorchid or cryptorchid hounds without breed disqualifications may be entered; hounds with breed disqualifications are not eligible to enter except in the Single Stake • Hounds not present at the time of roll call will be scratched • All hounds will run twice, in trios if possible or braces (except in the Single Stake), unless excused, dismissed or disqualified • Hound certification runs will be offered Saturday, 3 PM

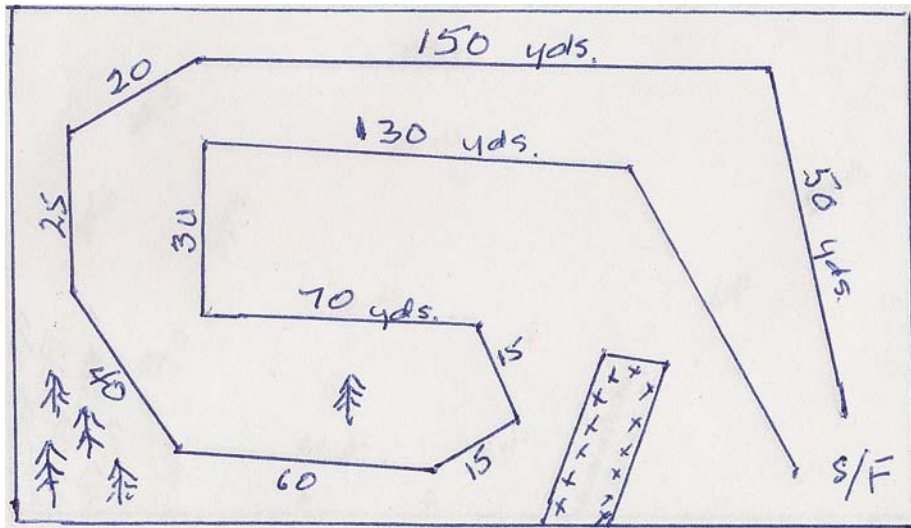
