INSPECTION/ROLL CALL: 9:00 a.m. followed by the draw.

Ribbons: BOB through NBQ. Rosette for BIF. Trophies offered for BOB and BIF.

Breed & Eligibility: Only purebred Afghans, Azawakhs, Basenjjs, Borzoi, Cirneco dell'Etnas, Greyhounds, Ibizan Hounds, Irish Wolfhounds, Italian Greyhounds, Pharaoh Hounds, Rhodesian Ridgebacks, Salukis, Scottish Deerhounds, Sloughi, Whippets and Provisional breeds, if any, may be entered in the regular stakes. Limited stake breeds, if any, are entered in the Limited Stake and currently include purebred Chart Polskis, Galgo Espanols, Magyar Agars, Peruvian Inca Orchids, Portuguese Podengos and Silken Windhounds.. All entries in the regular stakes shall be individually registered with the AKC, UKC, NGA, FCI, CRN, SPDBS. Dogs with an indefinite Listing Privilege (LPN) or a Purebred Alternate Listing (PAL) from the AKC shall be considered registered with that body. Limited and/or Provisional stake entries shall be individually registered with the appropriate registry. A photocopy of acceptable registry must be submitted with a hound's first ASFA field trial entry; this requirement is waived for Greyhounds registered with the NGA registry.

INCOMPLETE, UNSIGNED, CONDITIONAL OR UNPAID ENTRIES WILL NOT BE ACCEPTED.

Open Stake: Any eligible sighthound, excluding ASFA Field Champions of record. **Field Champion Stake:** Any ASFA Field Champion. **Veteran Stake:** Any eligible hound whose age is at least six years, except Irish Wolfhounds whose age shall be at least five years, and Afghan Hounds, Ridgebacks and Whippets whose age shall be at least seven years. Points & placements go toward V-FCH & V-LCM titles. **Limited Stake:** Any eligible sighthound of a Limited stake breed that has met certification requirements. Not eligible to compete in Best of Breed or Best in Field. **Single Stake:** Any eligible sighthound including those disqualified to run in other stakes. Points are not awarded. Hounds are not eligible to run in BOB or BIF.

Best in Field will be offered Saturday and Sunday

All entries must be one year or older on the day of the trial. Stakes will be split if the entry in any one stake is 20 or more at the time of the draw. Hounds will run twice, in trios if possible, or braces, unless excused, dismissed or disqualified. Bitches in season, hounds with breed disqualifications, and lame hounds will be excused. Spayed, neutered, monorchid and cryptorchid hounds without breed disqualifications may be entered. Hounds with breed disqualifications are not eligible to enter except in the Single Stakes. Hounds not present at time of roll call will be scratched. Hound certifications will be offered Saturday morning before the trial – limited to 6 hounds. Trial will be held regardless of weather conditions. **If this is the hound's first ASFA trial a signed ASFA Certification or Wavier must be included (not required for Single Stake). A photocopy of the hound's individual registration from an acceptable registry must also be included, NGA Greyhounds are exempt. All hounds must have a registration number or your entry will not be accepted. Persons exhibiting unsportsman like conduct detrimental to ASFA, this club, any hound or other person will be asked to leave the trial site.**

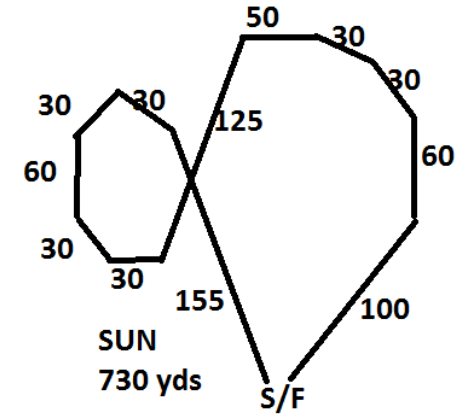
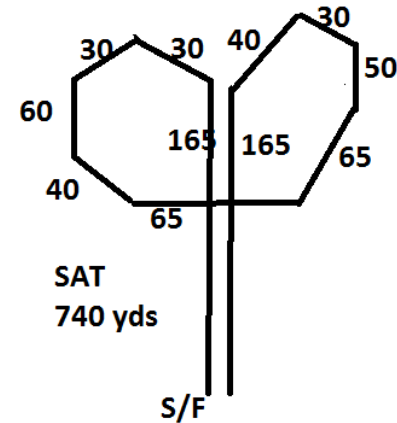
EQUIPMENT:
